Client Situation

CPB Contractors is the Australasian construction company of the CIMIC Group delivering major projects across all sectors of the construction industry, including roads, rail, tunnelling, defence, building, and resources infrastructure. Keeping people safe is CPB's absolute priority and underpins everything they do.

With the construction industry shut down for two weeks in Melbourne and regional Victoria, Australia, following multiple outbreaks of COVID-19 and compliance concerns, CPB was faced with demonstrating compliance with CHO directions across all sites prior to the reopening, and allowing workers to return to work.

Challenges

CPB with over 20,000 workers at over 10 sites, and thousands of contracting companies in Melbourne and Victoria, was facing the following challenges for a successful return to work, and the continuity of operations for the construction industry:

- **Rapid implementation of the requirements**
With an extremely tight timeframe to implement, the need to have a viable, and instantly deployable and scalable solution
- **Worker vaccination documentation**
The requirement of workers to show documented evidence to CPB of 1 dose of vaccine before the return-to-work date of October 5 and the ability to upload the documentation into the system
- **Validation and electronic capture of information for site access**
Ability to provide rapid, and on the spot validation of vaccinations, appointments, and exemptions to having the vaccine, for site access to be granted to visitors, employees, and contractors, and instantly update against the worker's profile in the Enterprise Protection Platform (EPP)
- **Alerts and notifications**
Have the ability of alerts and notifications for reminders of second doses and boosters
- **Reporting**
The capability to track & report at any time on the progress of vaccinations
- **System adaptability and scalability**
With ever-changing compliance requirements and regulations, the ability to adapt forms and workflows to scale when the need arises
